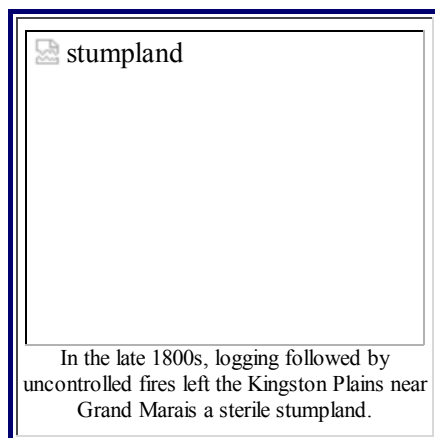

Speak Up for Michigan's Natural Heritage!

A century back, Michiganders watched helplessly as our state's forests and ecosystems were destroyed by loggers, setting back economic development, destroying wildlife habitat and fisheries, and impoverishing rural residents. **That was long ago, but equally devastating threats to Michigan's rich diversity of ecosystems exist today, which is why the Michigan Department of Natural Resources' Living Legacies Biodiversity Stewardship Areas program is so important.** It's a smart strategy to make sure our state's natural heritage is protected in perpetuity, without compromising other uses of our forests.

Through BSA, scientists, recreational groups, hunters, anglers, loggers, and others worked together to plan how to ensure the best ecosystem examples are sustained indefinitely. **Yet, some timber industry lobbyists and agency officials want to stop scientific management under the BSA program** and appear unwilling to leave any ecosystems intact for future generations. DNR Director Rodney Stokes has scaled back the program and put timber production above camping, hunting, trail usage, fisheries, and every other public land use. Now, **legislators may be poised to destroy this visionary program**, despite its broad support, strong scientific basis and critical role in maintaining healthy, functioning habitat for the future.

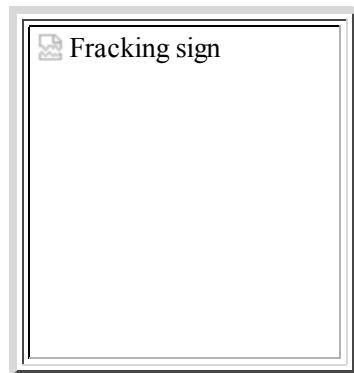
Michigan Senate Decides You Don't Need Clean Drinking Water

Last week, the Michigan Senate passed a package of bills that could have serious implications for the quality of our drinking water. **Senate Bills 528-533 would weaken the state's safeguards for underground fuel tanks used to store petroleum and hazardous waste.** Such tanks have been known to leak and contaminate groundwater, which is the source of drinking water for nearly half of all Americans. The EPA reported that there are **already over 9,000 leaks from underground storage tanks in Michigan** that are still waiting for cleanup because of insufficient funding – and these bills would simply add to that backlog.

Senate Bills 528-533 would directly lead to the contamination of more drinking water by:

- Making owners less liable for the environmental damages caused by their leaking tanks.
- Creating an industry controlled panel to resolve any disputes over cleanups.
- Limiting the role of state government in ensuring cleanup standards are met.

Fracking = Earthquakes + Polluted Air + Poisoned Water

We've known for a while that **hydraulic fracturing (a.k.a. "fracking") for natural gas can contaminate our water**, but last month we learned it caused **multiple earthquakes** in Ohio, in the wake of similar events in Oklahoma and Arkansas. And now, scientists are warning that fracking can **destroy air quality**, too! So, what can you do to make sure these things don't happen in Michigan? Screenings of *Carbon Nation* Coming Soon to a Town Near You!

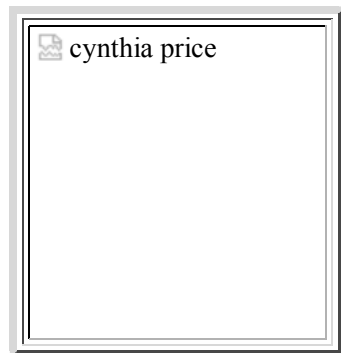

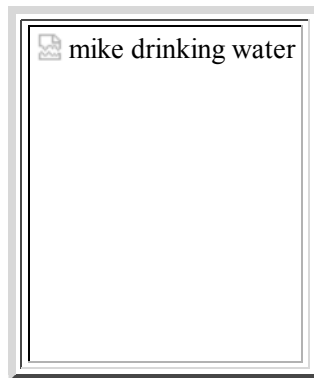

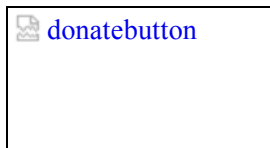
